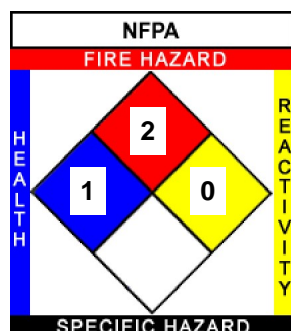

5 FIRE FIGHTING MEASURES
